The Roscommon County Board of Commissioner's met on Thursday, March 19, 2020 for a Special Meeting. The meeting was held at the Roscommon County Building, 500 Lake Street, Roscommon, MI 48653. Chairman Robert E. Schneider called the meeting to order at 10:00 am.

## **Unfinished Business/New Business:**

a. COVID19 Closure Planning – Steve Nielsen discussed the planned two-step cleaning procedures for the building. Treasurer Ragan will have a recorded message directing taxpayers on how to pay their taxes. Foreclosures are extended until May 29, 2020. Judge Jernigan presented the Emergency Operations Plan for the Courts. A drop box will be available Monday - Friday from 8 a.m. - 11 a.m. Any court functions required to continue will do so as advised by SCAO. Prosecutor Beebe indicated that her staff will work remotely and report to the courthouse as needed to handle court matters. Sheriff Stern indicated that measures will be taken to limit contact as much as possible throughout his department. IT Director Bendily shared that he and Pat have been working with departments to assist them in being able to work remotely when possible. One of them will be in the office each day to assist as needed. Animal Control Director Mendyk indicated that Animal Control will be available to answer calls, deal with emergencies, with limited access to shelter. Staff will be reporting to feed and care for the animals. 911 Director Stringham has restricted access to employees only into Central Dispatch. He has a letter and policy for the commissioners to approve. Veterans Affairs Director Nemeth stated that he will be assisting veterans remotely during this time. Clerk/ROD Stevenson shared that her office will have limited staffing and be working Monday, Wednesday and Friday's from 8:00 a.m. – 11:00 a.m. Elections and property records are deemed critical infrastructure and the filing deadlines for elections have not changed. Mail will continue to be processed and placed in each department's mailboxes. Most offices will be available remotely to continue essential duties. Emergency Management Manager Mike Beaty will be on call 24/7.

Commissioner Milburn read a brief statement.

Class A payments will be suspended for two weeks. If there are any emergency issues please contact Jodi for assistance.
