Historic Facts for Roscommon County

These facts were found in many of the articles that have been written regarding Roscommon County.

Roscommon County was first named Mikenauk County in 1840 honoring Chippewa Chief of the early 19th century

Changed by Legislation in 1843 – State Rep Charles O’Malley, from Roscommon Ireland, was instrumental in organization of the initiative to change the name to Roscommon County.

Roscommon is Irish “Ros” means wooded promontory or pleasant place. “Coman” is an Irish saint.

Only 3 townships existed in 1875 Denton, Higgins and Roscommon.

Houghton Lake was named for Douglass Houghton, “boy geologist”, one of Michigan’s most useful sons, who drown in Lake Superior in 1845.

In the late 1800’s the Michigan Central Railroad come into Roscommon on its way to the straits and became a rail transport of logs from this area. This station was named Roscommon Station.

Roscommon was one of the originators of the industry of extracting turpentine from pine stumps.

S.W. Higgins, topographical engineer, is the man for whom Higgins Lake was named in 1839.

In 1870 Henry Stephens established a lumber business in St Helen which produced more than a billion feet of lumber within 14 years.
