The Roscommon County Board of Commissioner's met on Wednesday, May 12, 2021 for a Regular Meeting. The meeting was held at the Roscommon County Municipal Building, 500 Lake Street, Roscommon, MI 48653 and was accessible online via ZOOM. Chairman Robert E. Schneider called the meeting to order at 10:07 a.m.

The Pledge of Allegiance of the United States of America was recited.

Motion by Muckenthaler, Second by Russo, to approve Board of Commissioner's Regular Meeting Minutes for April 14, 2021 and April 28, 2021 and Special Meeting Budget & Finance Committee of the Whole on April 28, 2021. Public Comment: Emil Bellenbaum spoke regarding the COA. Leroy Johnston spoke regarding the hybrid meeting.

Administrator/Controller's Report: Administrator/Controller Valentino shared that a brief was filed by our attorney in the Ostergren et al v Roscommon County lawsuit. Zielke v Roscommon is slated for pretrial in late 2021 with depositions and fact finding likely to happen in 2022. An official notice was filed regarding the POAM Arbitration. Valentino applied for an extension of the current EGLE permit for the Houghton Lake - Lake Level Control Structure and submitted a liability claim for the initial emergency repair and the engineering bid packet is complete. The 2020 Audit is in progress. Valentino received an update on the American Rescue Plan Funds and was provided with a link to the Final Rule that she will need to review. Treasurer Ragan has created a separate bank account for funds to be placed once received. Gypsy Moth Lead and Human Resources have updated job descriptions and there is a part time E911 position being created. The Gypsy Moth 2021 spray will likely start May 20th and continue until finished. Gerrish Township Supervisor Udy has been in contact regarding the Higgins Lake sewer project and engineering firm Fleis & Vandenbrink are available to present to the commissioners at the May 26 work session. Valentino attended Michigan Virtual Legislative Issues and caution is advised regarding the American Rescue Plan. There are several federal bills that would expand broadband grants to rural areas. It is strongly suggested to research the spending of the funds to make sure there isn't another way to fund the projects. Public participation is advised for the planning, review and decision making to ensure transparency. The property exchange agreement for the Blodgett Memorial Airport Runway 36 may enter final agreement stage by May 31st. The CDC has updated recommendations for fully vaccinated people.
